

SPRING INTO SAVINGS SWEEPSTAKES

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY:** The Spring Into Savings Sweepstakes ("Sweepstakes") is open to individuals 18 years of age or older as of date of entry and who are legal residents of the fifty (50) United States and the District of Columbia. Void wherever prohibited by law.
